Beasley Loses Battle With Cancer

A pillar in the Coats community has passed on. Former town board member Max Beasley died Thursday morning after battling cancer for several months. He was 77. Mr. Beasley served the board as commissioner for 12 years before calling it quits last year. He decided not to run for re-election due to his failing health.

"It's a big loss to the community and his family," said B.W. Holland, a close friend and another former town commissioner. "He was a great friend and a mentor to me. It's truly going to be a loss, but at least he won't suffer anymore," Mr. Holland said.

Mr. Beasley lived at 323 E. Main St. in Coats with his wife Dovie Davis Beasley. He had one son, Max Duane of Goldsboro, and three grandchildren, Zabrina, Susan and Stephanie.

He served at Coats First Baptist Church as a deacon and retired after 30 years of employment with GMAC. He also served in the Navy. However, it was his involvement in Coats politics and town business for which he was most well known. He was respected for his strong convictions and belief in the betterment of the town.

Gale Spears served on the board with Mr. Beasley for eight years and considered him a friend.

"He loved Coats and he was always concerned with the well being of the residents of this city," she said. "He was a joy to work with; he is really going to be missed, I'll tell you that." She said he had strong opinions about how town business should be conducted. "Max and I sometimes didn't agree on everything, but we had a very good working relationship and he was one that would quickly say 'I was wrong, you were right' and we both did that the time we were on the board together, which was about eight years," she said. "We had a very respectful working relationship because we both had the same goal and that was to do what is best for the Town of Coats."

Johnny Shull, the former mayor of Coats when Mr. Beasley was serving on the board, also respected him for taking a stand.

"It was certainly an honor to serve with Max, and while he and I certainly had our disagreements on policy and political decisions, he was a fine man and certainly he and I worked well together and I greatly respected him," he said. Mr. Shull recalled the first time he got a taste of how concerned Mr. Beasley was with the well being of Coats. "My best memory of Max was that he invited me over to his house right after we got elected on a Saturday morning and we probably spent six or seven hours together talking about issues," he said.

Mr. Holland explained just how much influence and impact Mr. Beasley had during his years in Coats.

"He has left a good legacy," he said. "He is the one who got sewer in town, he had a big part in that and of course he worked hand in hand with a lot of people with the Centennial Square. Max did a lot of things for the community most people didn't even know about," Mr. Holland said.

Donation Of Time, Energy

Gayle Sorrell, who helped head up the Cenntennial Project, said Mr. Beasley donated his time, energy and talent of painting to spruce up sites during last year's Cenntennial celebration. She said he painted the mural of Alton Stewart (the late Coats aviator) on a wall downtown and also painted a mural on a wall in the museum. She said his talent was God-given and he never charged for it.

"That man cannot be described with just a few little words," Mrs. Sorrell said. "I guess the thing I think about Max, because he was out here so much with the Cenntennial, is that he was a true Southern gentleman." She said instead of spending his retirement relaxing, he decided to move back to his hometown and better it. "This is a man that went away, had a very high position and decided he should serve Coats," she said. "He had nothing to gain except to love his community."

Though he never had the privilege of serving with Mr. Beasley, Marshall Miller, the current Coats mayor, knew him and his legacy.

"I was very saddened by today's news," Mayor Miller said Thursday. "I had gone recently and seen Max and it was a surprise to me, because when I saw him he looked good, and they were planning on sending him home. I think that Coats lost a great citizen and the town is not going to be the same without him," he said.
